Welcome to the 2017 V-Oscars Nomination Survey! We appreciate the time you are taking to recognize an **outstanding company** that has given back to the community. This survey uses a combination of yes/no and short answer questions to better understand the nominee's contribution. Your thoughtful responses will provide the information the Judging Committee requires to assess the most deserving candidate for each award.

### **Eligibility and Nomination Criteria:**

The *Corporate Volunteer Engagement Award* is presented to a company/business located in Peel (Mississauga, Brampton, Caledon), who:

- has demonstrated exemplary voluntary involvement and commitment to Corporate Social Responsibility (CSR)
- was able to involve their staff in activities or events, that has directly impacted one or more community service organizations
- is able to demonstrate overall positive/successful results for group/team involvement through ongoing support of a community service organization either through a “charity of choice” or long-term partnership

**Note:** Nominations can ONLY be made by active Volunteer MBC Agency Members **in good standing** who provide service in Peel, or by any of the staff or Board of Directors of Volunteer MBC. To learn more about membership, [CLICK HERE](#). To renew your membership, [CONTACT US](#).

Recipients of the *Corporate Volunteer Engagement Award* are selected by an independent Judging Committee and will be announced at Volunteer MBC's "The V-Oscars" Volunteer Recognition Awards Gala, being held on Thursday, April 27, 2017 in Mississauga.

**Note: Each nominee will receive one (1) free ticket to attend the event.**

Only one recipient will be awarded, per community (Mississauga, Brampton, Caledon), per fiscal year. If there is no recipient nominated from a specific community, the Judging Committee will be granted the authority to select additional recipients so that there will be a maximum of three recipients in total.

### **Nomination Guidelines and Submission:**

Please read through this list below and ensure that your nomination complies with all the guidelines.

1. Nominee must meet the nomination criteria outlined for the *Corporate Volunteer Engagement Award*.
2. Nominator must obtain the consent of the nominee prior to submission.
3. By submitting the nomination form, each nominator and nominee: Consents to participating in the awards program and in the nomination process; Consents to the use of the nominee's name, photograph and nomination material in any awards related promotion or publicity carried out by Volunteer MBC.
4. By submitting the nomination form, each nominee agrees to participate in all awards-related activities and functions as appropriate, including the Volunteer MBC Volunteer Recognition Awards Gala, which will be held on Thursday, April 27, 2017.
5. Each organization may submit only one (1) nomination for the *Corporate Volunteer Engagement Award*.
6. The decisions of the Judging Committee are final.
7. Nominations and all supporting materials become the property of Volunteer MBC.
8. In accordance with the Freedom of Information and Protection of Privacy Act, personal information about nominators and nominees is collected for the sole purpose of administering the Volunteer MBC Volunteer Recognition Awards Program. It will be used to select and publicize the achievements of the recipients.
9. Nominations that are incomplete or do not comply with these guidelines may be disqualified. Volunteer MBC takes no responsibility for incomplete, inaccurate, lost or late nominations.




