## 2. Financials

- Ting Guo, Volunteer MBC Board Treasurer presented the 2022 Auditor's Report and Audited Financial Statements. Kha Dang Auditor representing Dang and Associates, CPA, was present and available to answer any questions.
- 2022 was a tough year for Volunteer MBC as it was for many non-profit organizations w.r.t inflation rates, labour, lack of funding and volunteer shortages, while demand for services increased.
- \$170K of federal, provincial, and regional funding making up 31% of total revenues.
- \$76K of funding came from the cities of Mississauga Brampton and the Town of Caledon 14%
- \$173K of funding came from several foundations including the Ontario
   Trillium Foundation and the United Way of Greater Toronto 31%
- \$131K from our core programs, Memberships, Learning Centre, and Fundraising Events – 24%
- Our revenue sources decreased by \$250K from the previous fiscal year i.e., a 31% below the prior year's revenues. Notably, \$145K of this shortfall relates to the available government funding – which was almost a 90% decrease over prior year.
- At the end of 2022, Volunteer MBC recorded the net asset balance of \$253K.

There was a motion to accept the 2022 audited financial statements by Myrna Adams Seconded by Lee Velardo.

- Community engagements increased virtual and in person. Overall, there has been a big increase on our online presence.
- The 2022 National Volunteer Week commenced with a momentous inaugural flag hoisting ceremony in Mississauga, centered around the theme of 'Empathy in Action.'
